Önsöz

Elinizdeki kitabın ismini *Demokrasi, Demokratikleşme, Demokratikleşmenin Geri Çevrimi ve Karşılıklı Bağlılıklar* koymalıydım ancak bunu göze alamadım. Bu kullanışsız, tuhaf başlık birçok okuyucuya kitabı çok önemli olan konusundan uzaklaştıracaktı. Ancak umuyorum ki, kitabı sonuna kadar okuyanlar, demokrasi olarak adlandırılan ideal politik sistemi basitçe tanımlamanın, sonrasında da bu sistemin hangi koşullar altında ortaya çıkabildiğini ve de ayakta kalabildiğini anlatmaya çalışmanın “neden bir şey ifade etmeyeceğini” anlayacaklardır. Demokratikleşme, her zaman tamamlanmadan kalan ve sürekli olarak tersine çevrilme riski alan –demokratikleşmenin geri çevrimi– dinamik bir süreçtir. Zıt yönlerde hareket eden, yakından ilişkili süreçler hem demokratikleşmenin hem de demokratikleşmenin geri çevriminin ortayamasına yol açarlar. En azından elinizdeki kitap enine boyuna bunu tartışmaktadır.

Uzun yillardır, demokrasi demokratikleşme ve demokratikleşmenin geri çevrimi konularının çalışılması gerekliliğini aşama aşama fakat engellenemez bir şekilde hissediyorum. Bu çalışma, hayat boyu süren, sıradan insanların önemli kolektif taleplerde bulunmak için kullandığı araçların, yani çekişme repertuarlarının nasıl çeşitlendiğini ve değiştığını açıklama çabasından ortaya çıktı. Bu meseleyi tarihsel perspektiften dikkatli bir şekilde ele alan herkes eninde sonunda iki gerçeğin farkına varacaktır: İlk olarak, demokratik olan ve olmayan rejimler çok farklı çekişme repertuarları içerirler ve aslında etkili repertuarlar, belli bir rejimin demokratik olduğunu ya da olmadığını saptamaya yararlar; ikinci olarak, demokratikleşme ya da demokratikleşmenin geri çevrimi ortaya çıkarken, repertuarların çarpıcı değişimleri de ortaya çıkar. Örneğin, iç savaşlar demokratik olmayan rejimlerde yoğunlaşırken, toplumsal hareketler neredeyse yalnızca demokratik rejimlerde şekillenirler. Bağıntı kusurlu ve olumsaldır. Dolayısıyla, demokrasinin yalnızca bir dizi talepte bulunma performansı gerektirdiği, demokrasi olmayanın da başka bir performansı gerektirdiği durumda olacak olandan daha zorlayıcı ve ilginçtir. Halkın mücadelesi demokratikleşmenin gerçekleşip gerçekleşmeyeceği ve nasıl gerçekleşeceği konusunda etkilidir. Bu kitap nasıl ve neden diye sormaktadır.

Elinizdeki kitabı belki de yüzde 20'si, özellikle önceki iki Cambridge Yayınları'ndan çıkan kitapta –*Contention and Democracy in Europe, 1650-2000* (2004) [Avrupa'da Çekişme ve Demokrasi] ve *Trust and Rule* (2005) [Güven ve Yönetim]– başka bir şekilde yayımlamış olduğum bilgileri içermektedir. Bu toplu ödünc almayı savunmama izin verin. Bu kitapta yer verilen bilgiler, bu bilgilere olabildiğince yeni anlamlar kazandıran farklı bağlamlarda ortaya çıkmaktadır. *Contention and De-*

mocracy demokratikleşme ve halk mücadelelerinin karşılıklı bağlılığını göstermek için Avrupa rejimlerinin karşılaşmalı tarihlerini kullanırken, *Trust and Rule* kişiler arası güven ağlarıyla siyasi rejimler arasındaki bağlantılardaki değişimi ve çeşitlenmeyi tahlil etmiştir. Her iki mevzu mevcut kitapta yeniden ortaya çıkar ancak şimdi daha kapsamlı bir soruya bağlıdır: Demokratikleşme ve demokratikleşmenin geri çevrimi genel olarak nasıl gerçekleşmektedir?

Kitap, önceki yayınlarimdaki bazı tartışmaları –özellikle de konu, demokratikleşme ve demokratikleşmenin geri çevrimi, faktörler olarak zor iktidarının özerk merkezleri ve kamu politikalarının devlet üzerindeki denetimi olduğunda– netleştirmekte ve gözden geçirmektedir. Bu çalışma tarihsel perspektifi devam ettirmekle birlikte, demokrasiyi önceki ele alışlarımından daha fazla, yakın geçmişe ve çağdaş dünyaya yoğunlaşmaktadır. Umarım bu kitap, günümüzde demokrasi üzerinde yaşanan mücadeleleri inceleyen öğrencilere, tarihsel-karşılaştırmalı bir analizin bu endişe verici alandaki değerini fark etmeleri konusunda yardımcı olur. *Demokrasi’yi* her durumda, konuya dair tüm çalışmalarımın doruk noktası ve sentezi kabul ediyorum.

Kitaptaki yardımlarından dolayı beş kişiye teşekkür etmek istiyorum. Lisansüstüden sınıf arkadaşım Raymond Gastil’i on yıldır görmüyordum ancak Gastil, tartışmalarımın işaret ettiği, demokratikleşme ve demokratikleşmenin geri çevrimi daha doğrudan ölçüyü için kitabın referans olarak dayandığı Freedom House değerlendirmelerini kullanmama onayak oldu. Sık sık ortak çalışma yürüttüğüm Sidney Tarrow taslak metni okumadı ancak Tarrow’un, müşterek ve ayrı yayınlarimdaki ilintili fikirleri aralıksız sorgulaması, rejim, devlet kapasitesi ve demokrasi gibi kavramların içinde pusuda bekleyen tehlikelere karşı beni uyardı. Viviana Zelizer uzman olmayan keskin bakış

açısıyla metnin tamamına hızlıca göz attı, dikkatimi etkili bir şekilde bilinmezliklere ve uygunsuzluklara çekti. Son olarak da, Cambridge University Press adına sempatik fakat talepkâr iki anonim okuyucu, sizin yararınız ve benim yararım için kitapta-ki birkaç kavramı ve tartışmayı netleştirmemi ve/veya savun-
mamı istedi.

Demokrasi Nedir?

1996 yılında, Kazakistan'ın dağılan Sovyetler Birliği'nden ayrılımasından beş yıl sonra Devlet Başkanı Nursultan Nazarbayev, danışmanlarına yeni bir anayasa taslağı hazırlamıştır. Taslağın onaylanması için ülke genelinde yapılan referandum büyük destek almıştır. Yeni anayasanın birinci maddesi şunu ilan etmektedir:

1. Kazakistan Cumhuriyeti, en yüksek değerleri birey, bireyin yaşamı, hakları ve özgürlükleri olan demokratik, laik ve sosyal bir hukuk devletidir.
2. Cumhuriyet'in işleyişinin temel ilkeleri toplumsal uyum ve siyasi istikrar, tüm ulusun yararına olan ekonomik kalkınma; Kazak vatanseverliği ve devlet işlerine ilişkin en önemli meselelerin ulusal referandumda ya da Parlamento'da oylama dâhil demokratik yollarla çözülmESİdir. (Kazak Anayasası, 2006)

Öne çıkan “toplumsal uyum ve siyasi istikrar” ifadesi mesafeli bir devletten ziyade, fazlasıyla ihtiyyatlı bir yönetici imajını akla getirmektedir. Buna karşın, Anayasa açık bir şekilde Kazakistan'ın demokrasıyla yönetildiğini iddia etmektedir.

Ülkeyi dışarıdan gözlemleyenler Kazakistan'ın bu iddiasına karşı çıkarlar. New York merkezli demokrasiyi izleme örgütü Freedom House, her yıl tanıtan devletleri siyasal haklar ve sivil özgürlükler yönünden, 1'den (yüksek) 7'ye (düşük) kadar derecelendirmektedir (Gastil 1991). Kutu 1-1 Freedom House'un kriterlerini özetlemektedir. Bu kriterler, kurumsallaşmış muhalefetten kişisel özgürlüklerle kadar çok çeşitli yurttaş hak ve özgürlüklerini kapsamaktadır. Freedom House, 2005 yılında Kazakistan'a siyasal haklarda 6 (çok düşük), sivil özgürlüklerde ise 5 (neredeyse aynı derecede düşük) vermiştir. Rapor ülkeyi "özgür değil" şeklinde sınıflandırmıştır. Rapor şöyle başlamaktadır:

Devlet Başkanı Nursultan Nazarbayev'e sadık olan siyasi partilerin parlamentodaki hâkimiyetleri, uluslararası gözlemcilerin, temel demokratik standartları karşılamaktan uzak olduğu gereğinceyle eleştirdikleri Eylül 2007'deki meclis seçimlerinden sonra da devam etmiştir. Muhalefetten yalnızca bir milletvekili seçilmiştir ki o da seçimlerin kusurlu doğası nedeniyle milletvekili koltuğunu protesto ederek reddetmiştir. Bu sırada, kilit noktadaki önemli üst düzey yetkililerin istifaları Nazarbayev hükümetinin içindeki iktidar mücadelelerini ve ihtilafları gündeme getirmiştir. (Freedom House Kazakistan 2005)

Kazakistan'ın uluslararası ekonomiye ve uluslararası politikalara katılmıştı, Nazarbayev'i ülkenin Orta Asya'daki komşularının benimsediği türden, bariz bir otoriteryanızmden kurtarmış olsa da (Schatz 2006), bu, Nazarbayev'in kendi çıkarları için hükümet aygıtını acımasızca manipüle etmesine engel olmamıştır. Nazarbayev, Aralık 2005'te oyların %91'ini alarak üçüncü kez altı yılına devlet başkanı seçilmiştir. %75'ten daha fazla bir çoğunlukla seçilen –özellikle de yeniden seçilen– devlet başkanı adayları gördüğümüzde rejimin göstermelik seçimler yaptığı hipotezini akılda tutmalıyız.
